**The annual statewide tornado drill** will take place on Tuesday, March 15<sup>th</sup> at 1:30 p.m. Calhoun sirens are scheduled to go off at that time. If there is bad weather in the area, the drill will be rescheduled.

This is a good time to make sure your entire family knows where to go and what to do in the event of a real tornado. Have a family tornado plan in place, based on the kind of dwelling you live in. Know where you can take shelter in a matter of seconds, and practice a family tornado drill at least once a year. Have a pre-determined place to meet after a disaster. Flying debris is the greatest danger in tornadoes; so store protective coverings (e.g., mattress, sleeping bags, thick blankets, etc) in or next to your shelter space, ready to use on a few seconds' notice. When a tornado watch is issued, think about the drill and check to make sure all your safety supplies are handy. Turn on local TV, radio or NOAA Weather Radio and stay alert for warnings. Forget about the old notion of opening windows to equalize pressure; the tornado will blast open the windows for you! If you shop frequently at certain stores, learn where there are bathrooms, storage rooms or other interior shelter areas away from windows, and the shortest way to get there. If you are planning to build a house, consider an underground tornado shelter or an interior safe room.

**If you need shelter during a storm warning,** the Calhoun Baptist Church located at 307 S. College Street will be opened.



**The Presidential Preference Primary** will be held on Tuesday, March 15<sup>th</sup>. Calhoun City Hall is the polling place for Tebo and Springfield Townships. Polls open at 6 a.m. and close at 7 p.m. Handicap parking and accessibility is available at the rear of the building.

**The General Municipal Election** will take place on Tuesday, April 5<sup>th</sup>. Calhoun citizens will be voting on a proposition to continue to apply and collect the local sales tax on the titling of motor vehicles, trailers, boats and outboard motors that are purchased from a source other than a licensed Missouri dealer? Here is some general information concerning the tax that may answer your questions:

*How does the tax affect me?* The tax only applies to you if you purchase a motor vehicle, trailer, boat or outboard motor from out-of-state. Similar purchases made in-state will be subject to the local sales tax regardless of the vote on this ballot question.

*What is the sales tax about?* A Missouri Supreme Court Case (Street vs. the Director of Revenue) in 2012, followed by subsequent state legislation (HB 184/SB 182) in 2013, required that cities without a use tax (such as Calhoun) must receive voter approval by November 2016 to continue sales tax collections on purchases of out-of-state motor vehicles, trailers, boats and outboard motors.

*Is this a new tax?* No. The city has collected this tax for many years. The question is on the ballot only as a result of the Missouri Supreme Court decision and the state legislation that followed. If the question is not placed on the ballot, or if the tax is discontinued by voters, the tax would cease to be collected beginning January 2017.

Where do the collections from the tax go and what impact does the tax have on Calhoun revenues? 100% of the funds received from this tax are deposited into the street fund. This money is used for things such as gravel, street repair, street lighting, snow removal and street signs. It is estimated that the budget impact of discontinuing collection of the out-of-state vehicle sales tax will result in an annual loss of approximately 21% within the street fund. Services would have to be cut to account for this loss of funding.

#### What does a "Yes" or "No" vote mean?

- A "Yes" vote means the existing tax will continue; no new tax will be implemented.
- A "No" vote means that local sales taxes will only be collected on eligible in-state purchase. Local sales tax collections on eligible out-of-state purchase will end and the revenues the City is currently receiving will be lost.
